2. Preparation of your AJAS article

Then, use this template to transform your paper by doing the following :

(1) At the beginning, compile the template and check that there are no errors.

(2) Check the packages used by the template. If you used other packages, add them and insert the commentary : (% Added packages) before you put them.

(3) Rename the template file as you want (So the original template is still available).

(4) Fill in the header (title, names, email, institution, abstract). Limit the abstract to 8 lines, at most. Also, pay attention to the following points.

(4a) Give **full names** of all authors in the following sequence : First name + middle name(s) + Last (family) name. (Please not initials)

(4b) Provide the emails of all co-authors

(4c) Do not use neither mathematical formulas nor citation (`\ref{...}` or `\cite{...}`). The abstract should not exceed 8 lines in the pdf after you compile your the latex file.

(4d) Give AMS 2010 Mathematics Subject Classification Objects in the file *classifications2010.pdf* in the template's folder.

(5) Delete all which is between (%Beginning of the Article) and (%End of the Article). Copy there your article.

(6) Empty the bibliography environment. Put yours there

(7) Do not forget to have the file `afrikaa.cls` and the file `logo_jas.png` in the folder containing your tex file.

(8) Run twice or more.

3. A writing style

we have chosen to have all new lines to begin without indentation. So :

a) Finish all paragraph - which is followed by another paragraph - by a **new line command** (`\newline` or `\\`), and next use a blank line

b) Begin the new paragraph by a **noindent command** (`\noindent`).
